### **Last day to Register is July 31, Saturday.**

Any submission after that date will be assessed a \$50 late fee.

The following items are required to be submitted/completed:

1. Full registration fee of \$450 (both men and women leagues)
2. Completed team roster form. (included in this packet)

\*\* Blank spaces on the roster name will be considered incomplete and will be returned. It is important to have the email address of the players on the team for the FASAMi mailing list, which will only be used for volleyball and events updates. FASAMi values your privacy and will never use your email for solicitations.

3. FASAMI Membership (renewal/new/upgrade) - \$8 for family or \$5 for individual

\*\* Each player must complete the online Membership Form found on this link: <http://fasami.org/joinus.html> Team Leaders will receive an update from the Membership Coordinator. Your membership is not finalized unless FASAMi receives your membership dues (\$5 single and \$8 family). Kindly give your payment ONLY to your team leader/manager during the registration process. Failure to do so on time may result in a \$50 late penalty for your team. Thank you.

4. Signed TEAM Waiver and Conduct Forms (included in this packet)

\*\* A parent/guardian must sign for minor aged players (15-17 year olds).

5. Non-Filipino players must submit a copy/paper documentation of their marriage license, and
6. Managers/Team Leaders must sign the Rules and Regulations Form upon the start of the league.

### Important Rules and Regulations

Ø All regular season games are played for 55 minutes limit with each set to 25 rally points and up to 27 points cap. If the time runs out, whoever has the winning score takes the final set.

Ø May add players up to 3rd week (still 12 player roster limit). Must have all forms completed and membership fees paid prior to playing. Incomplete player registration results in ineligibility.

Ø Each player on the roster should have played at least 3 sets within the first 4 weeks to be able to play for the playoffs. This is to deter adding a player during playoffs that did not play during the regular season.

Ø **Teams may have as many non-filipino players married to a filipino/filipina but only 1 non-filipino can play per set. Not more than 1 non-filipino can play at the same time.**

Ø @Bailey's Gym: Absolutely no eating inside the gym. For those with a child/children, kindly keep them in check and make sure they do not play with or near the gymnastics equipment.
